01

POSI sends a simple contribution acknowledgment — not a sponsorship agreement.

03

Make Your Gift

Give by check, ACH, or credit card. Online donations generate an automatic tax receipt.

04

We Identify a Local School

POSI selects a K-12 school in your area for assessment. We'll let you know which school your gift helped.

05

Receive Your Tax Letter

Your official IRS-compliant acknowledgment letter is delivered within 2 business days of gift processing.
